SELF-ESTEEM. STUDENT TRANSFORMATION FROM AN "I'M NOT CAPABLE" ATTITUDE
TO AN "I CAN" ATTITUDE KEEPS VOLUNTEERS AND STUDENTS ENGAGED AND
EXCITED.

WHEN THE PROGRAM WAS BEING DEVELOPED, THE PROFILE OF THE WOMEN TO BE
SERVED WAS RESEARCHED TO DETERMINE WHAT TYPE OF BARRIERS WOULD HINDER
PARTICIPATION. IT WAS DISCOVERED THAT MORE THAN 90% OF THESE WOMEN ARE
SINGLE MOTHERS. CHILD CARE EMERGED AS A CRITICAL FACTOR AND WAS
INCLUDED IN THE PROGRAM. IN ORDER TO FACILITATE EXCELLENT ATTENDANCE, A
LIGHT MEAL IS SERVED TO THE FAMILIES PRIOR TO TRAINING CLASSES. ALL
THESE SERVICES ARE PROVIDED AT NO COST TO STUDENTS. THE ONLY COST TO
THE STUDENT IS HER STUDENT TRAINING MANUAL. IF SHE ISN'T ABLE TO PAY

THE FIRST CLASS BEGAN IN JANUARY 2003 AT A SINGLE LOCATION WITH SEVEN STUDENTS AND FOUR CHILDREN WHO WERE REFERRED BY WOMEN'S HAVEN, A LOCAL SHELTER FOR VICTIMS OF DOMESTIC VIOLENCE. WHEN THE THIRD SET OF CLASSES BEGAN, THERE WERE 36 STUDENTS WITH 66 CHILDREN REPRESENTING FOUR AGENCIES IN FOUR DONATED LOCATIONS. CONSOLIDATION TO A CENTRAL LOCATION BECAME POSSIBLE IN SEPTEMBER, 2006, WHEN THE LADDER ALLIANCE MOVED INTO A CENTRAL FACILITY INCLUDING OFFICES, CLASSROOMS, A DINING HALL AND CHILDCARE AREAS. THIS LOCATION IS EASILY ACCESSIBLE ON THE BUS ROUTES MAKING PARTICIPATION POSSIBLE FOR MANY WOMEN WHO HAVE NO TRANSPORTATION.
